

The Life of MRS. ARLENA WILSON SPANN

Arlena Wilson-Spann entered into life on November 30, 1936, in Bordeau, Kentucky, to the union of Reverend James Maylon and Willie Mae Tucker-Wilson, being the third child born at that time.

Early in life, her family relocated back to her father's birthplace in Lee County, Virginia. They lived there for several years until her parents and seven siblings moved to Loudoun County, Virginia seeking a better way of life for their family. *Arlena* received her formal education in the public school system of Loudoun County. She was baptism at the family church in Loudoun County, VA. *Arlena* faithfully attended church along with her parents and siblings. It was during one of these attendances that she met a young man in a gospel quartet who had a guest appearance one Sunday evening, whom she later married on July 14, 1952, by the name of Willie Lee Spann, Jr., making her *Mrs. Arlena Wilson-Spann*. After marriage, they moved to Washington, D.C., and of this union seven children were born; Willie Lee Spann III, David Lee Spann, Quintin Spann, James Edward Spann, Gary Andrew (Linett) Spann, Donald Lee Spann and their one & only daughter, Novella Spann-Isaac, preceded her in death. While raising her seven children, *Arlena* found time to incorporate her work ethic along with parenting. She worked from approximately 1959 until 1964 at the Prince George's General Hospital. After leaving there *Arlena* sought work at the Magnolia Gardens Nursing Home in Lanham, Maryland until she and her family relocated to Manning, South Carolina, where *Arlena* worked for several years at the Hampton Nursing Home. Eventually, she left that profession and began private duty work in a couple of homes in South Carolina. As a result, *Arlena* ended her career to remain at home with her husband who retired several years prior. Until her health failed, Arlena enjoyed her membership at Friendship A.M.E. Church.
